

The Metadata Manager has been redesigned to make data access intuitive and effortless, ensuring a pleasant user experience. It now has a card layout that enables you to search, view, and compare assets with ease. Its rich filtering options help you in precisely pinpointing the required information. ### **Proposed Assets**


