## New Features and Enhancements 14.1

### erwin Data Modeler

- erwin Data Modeler (erwin DM) is now available on macOS for all editions. This version supports all features of erwin DM.

RE and FE are supported only via JDBC connection to databases.

For information on installation, refer to the macOS installation section in the [Install erwin Data Modeler](#) topic.

- Google BigQuery support has been enhanced with:
  - New property sets for Table, Column, and View objects offer more flexibility.
  - The Function object now supports aggregate functions for SQL and JavaScript user defined functions.
  - Index object now supports search and vector indexes for improved search results and data retrieval.

- Snowflake models now support [Dynamic Tables](#) to simplify data engineering and enhance data transformation.
- Forward Engineering wizard now has a search box on the Object Filter tab. It enables you to search objects (tables or collections) for all SQL and NoSQL databases.
- The option to double-click an object to open the editor is now available for NoSQL models.
- Several defects have been fixed. For more information, refer to the [Fixed Issues List](#).

### erwin Mart Portal and erwin ER360

- Parallel job execution is now supported.
- The Session report now displays Group information for group users.
- Session report is now available for erwin ER360.
- The Profiles module now includes permissions for Views, Collection, and Worksheet modules.

## Known Issues

This section contains the known issues that you should review before using the application on Windows OS and macOS.

### Windows

SI No	Issue and Description
1	<b>Snowflake: The complete Timestamp function is not retrieved for the cloned Dynamic Tables during RES</b>  When you clone a Dynamic Table type while reverse engineering a Snowflake database using a script, the complete timestamp information for cloned tables is not retrieved.
2	<b>SQL Server 2019/2022: The column name for column store index is not updated in Alter Schema</b>  When you generate alter script for SQL Server, the column name is not updated for the column store index.
3	<b>&lt;Modification_Time&gt; tag's date format should be changed to 'yyyy-mm-dd hh:m-m:ss' in XML file format</b>  The XML file containing the <Modification_Time> tag value is displayed as 'mm/dd/yyyy' and time 12 hours with AM/PM format. Instead, the tag value should contain the date format as 'yyyy-mm-dd' and time should be in 24 hour format.
4	<b>MITI: 'Invalid bridge parameter value (version: 10.00)' is displayed in the import log file while using MITI import bridges</b>  'Invalid bridge parameter value (Version: 10.00)' warning statement is displayed when you import external files using MITI Bridges.
5	<b>erwin ER360 Annotation/Shape on Diagram</b>  In comparison for ER-diagram for Physical, the order is not same as that in erwin DM. Also, in erwin ER360 we see extra partition line.
6	<b>erwin ER360 displays subtype and super type relationship incorrectly</b>

## macOS

SI No	Issue and Description
1	<b>erwin DMcrashes while clicking on Next after connected to the DM through ODBC</b> erwin DM crashes on clicking Next after connecting via ODBC.
2	<b>Getting an error for Snowflake through the JDBC connection for "Snowflake JDBC Key-Pair Authentication Encrypted"</b> The error, "Snowflake JDBC Key-Pair Authentication Encrypted and Unencrypted", is displayed in the RE wizard.
3	<b>REDB: Error message is displayed while Reverse engineer from the database.</b> For Neo4j, an error occurs while running reverse engineering from database (REDB).
4	<b>Error message is displaying while adding new folder to erwin project</b>
5	<b>Email Notification is not working with outlook SMTP settings in Scheduler</b> While testing Email notification for Scheduler, the notification, "Test message has been sent" is displayed. However the recipient does not receive the email.
6	<b>DynamoDB local database is not connecting from erwin DM</b> DynamoDB local database does not connect when DynamoDB is installed locally.
7	<b>Model is not saving under default location when job is executed from Scheduler</b> For jobs executed via Scheduler, models are not saved at the default location, ./erwin/Data Modeler r9/Data/Models/.
8	<b>Query tool is not working and the Data Sources are not listing</b> In ODBC Data Sources "erwin_r9" and "erwin_r9_current" are not listed.

10	<b>The 3D style illustrations (Torus Style, Pie and Doughnut) are not being rendered on Object Count as well as Object Browser</b>
11	<b>Short cut keys are not working in the report designer page</b>
12	<b>Print preview does not display in report designer</b>
13	<b>Garbage characters are displayed in the Font drop-down options in the Report Designer</b>
14	<b>When we add and remove the ER Diagram/Subject area and then do Redo, we receive a GDM message.</b>
15	<b>Label text is missing in 'Records Count' page while performing 'Two Table RollUp' transformation</b>
16	<b>MITI import or Export throws error</b> MITI import or export logs an error, "Model BridgeList.XML file is invalid", in the log file.
17	<b>Black marks are displayed in Model Explorer for Annotation &amp; Domain Objects</b> Instead of appropriate icons, black boxes are displayed for Annotation and Domain objects in the Model Explorer.
18	<b>eMovies &amp; Publications models are not available under the My models folder</b>
19	<b>Models are not able fetched from mart repository while using MITI bridges</b> While using the Import from External Format wizard (MITI), models are not fetched from mart repository and an error occurs.
20	<b>The "Expand All (Ctrl -)" help text is not displayed when the mouse hovers on the 2nd icon in Object Browser in MacOS</b>
21	<b>The Node locked license code works as a Cloud based license code when activated online</b> The Node locked license code works as a Cloud based license code when activated
